- Note 1 The table above shows the division between restricted., unrestricted funds and designated funds including endowment funds
- Note 2 This consists of 212.529units (187.485Units) in M & G Charifund accumulation Units -Market Value 31/12/2007 £27,920 (187.485units 29/12/2006 £26,123.)
A Trustee has undertaken to make up the difference between the purchased Cost excluding reinvested income and Market Value -if less.
- Note 3 The freehold is vested in the official Custodian for Charities.
- Note 4 These have no Market Value
- Note 5 Sundial and equipment for the green having no Market Value
- Note 6 Designated funds are funds of unrestricted origin so designated by the Trustees. The balance of such funds at 31st December 2006 was £691.32. This amount is now classed as a creditor and is repayable on demand and is retained as an interest free loan
- Note 7 Accrued Interest plus taxation deducted and Monies awaiting encashment
- Note 8 Endowment Funds are monies subscribed by Patrons towards the long term upkeep of the Millennium Green such monies are invested to provide investment income and amounted to £14,911 (£9,568) at 31st December 2006
